CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 40016030.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file her February 2008 monthly simplified surety report by March 17, 2008. Said report was received by Petitioner on May 16, 2008.
2. Respondent failed to file her February 2008 monthly cash report by March 17, 2008.
3. Respondent failed to file her March 2008 monthly simplified surety report by March 17, 2008. Said report was received by Petitioner on May 16, 2008.
4. Respondent failed to file her March 2008 monthly cash report by March 17, 2008.

CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her February 2008 and March 2008 monthly cash reports and her February 2008 Simplified Surety reports.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **CENSURED**.

IT IS FURTHER ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she is to file her February 2008 and March 2008 monthly cash reports by June 15, 2008. If Respondent fails to file said reports, her license will be immediately suspended and will remain suspended until the reports are filed.


