**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800926/199495.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to file his February 2008 International Fidelity Insurance Company monthly surety report by March 17, 2008. Said report was hand delivered to Petitioner's Tulsa office on March 20, 2008, and received by the Oklahoma City office on March 26, 2008.
2. Respondent failed to file his March 2008 International Fidelity Insurance Company monthly surety report by April 15, 2008. Petitioner received said report on May 29, 2008.

3. Respondent failed to file his April 2008 International Fidelity Insurance Company monthly surety report by May 15, 2008. Petitioner received said report on May 29, 2008.

**CONCLUSIONS OF LAW**

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his February 2008, his March 2008, and April 2008 International Fidelity Insurance Company monthly surety reports.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined in the amount of **One Hundred Fifty and No/100 Dollars (\$150.00)**. Fine is to be paid immediately.


