1. Respondent failed to file her March 2008 monthly cash report by April 15, 2008. Said reports were received by Petitioner on July 14, 2008..


CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her March, April, and May 2008 monthly cash reports.

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is fined in the amount of **One Hundred and No/100 Dollars (\$100.00)**. Fine is to be paid immediately.




