
CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his April 2008 Safety National Casualty Corporation monthly surety report.

by the Respondent that she shall be and hereby is **CENSURED**.






