2. Respondent failed to file her May 2008 American Contractors Indemnity Company monthly surety bondsman report by May 15, 2008. Said report was received by Petitioner on June 17, 2008.

**CONCLUSIONS OF LAW**


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA.

ADMIN. CODE 365:25-5-36 by failing to timely file her April and May 2008 Safety National Casualty Corporation monthly surety bondsman report.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is fined in the amount of **One Hundred and No/100 Dollars (\$100.00)**. Fine is to be paid immediately.
