**ORDER**

The State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, states the following:

**JURISDICTION**

1. The Insurance Commissioner administers and enforces all provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59 § 1301 et seq.
2. Provided that all liability on outstanding bonds has been extinguished and upon written application, the Insurance Commissioner is authorized to release the deposits of a professional bondsman by written order. OKLA. STAT. tit. 59 § 1306(A)(5) and (6).

**FINDINGS OF FACT**

1. William Lawson was a licensed professional bail bondsman (license number 800840/200094) in the State of Oklahoma. However, he failed to renew his license by September 30, 2007. As a result, his license expired on October 1, 2007.
2. In accordance with OKLA. STAT. tit. 59 § 1306(A)(3), William Lawson has a Twenty Thousand Dollars (\$20,000.00) security deposit with the Insurance Commissioner.
3. William Lawson's current outstanding liability as of May 2008 is zero. (Exhibit 1)
4. William Lawson has submitted a written application for the release of his security deposit. (Exhibit 2)
5. That the Department has received certificates of non-liability from the Clerk of all Seventy-Seven (77) District Courts of Oklahoma and the two (2) Municipal Courts of Record in Oklahoma indicating that William Lawson has no outstanding liability in the State of Oklahoma (Exhibit 3).

**CONCLUSIONS OF LAW**

1. That pursuant to OKLA. STAT. tit. 59, § 1306(A)(5), any deposit made by a professional bondsman shall be released and returned by the Oklahoma Insurance Commissioner to the professional bondsman only upon extinguishment of all liability on outstanding bonds.

2. That pursuant to OKLA. STAT. tit. 59, 1306(A) (6), no release of deposits to a professional bondsman shall be made by the Oklahoma Insurance Commissioner except upon written application and the written order of the Commissioner.


3. That William Lawson has complied with the required provisions set out in OKLA. STAT. tit. 59, § 1306(A)(5) and (6).


**ORDER**
