STIPULATIONS OF FACT

1. Respondent failed to file her May 2008 Safety National Casualty Corporation monthly surety report and her May 2008 US Fire Insurance Company surety report by June 16, 2008. Said reports were received by Petitioner on August 18, 2008.


CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her May 2008 Safety National Casualty Corporation monthly surety report and her May 2008 US Fire Insurance Company surety report


