STIPULATIONS OF FACT

1. Respondent failed to file his May 2008 Fairmont Specialty Insurance Company monthly report by June 16, 2008. Said report was received by Petitioner on July 24, 2008.


CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his May 2008 Fairmont Specialty Insurance Company monthly surety bondsman report.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured**.


