STIPULATIONS OF FACT

1. Respondent failed to file her May 2008 International Fidelity Insurance Company monthly surety report by June 16, 2008. Said report was received by Petitioner on July 29, 2008.


CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her May 2008 International Fidelity Insurance Company monthly surety bondsman report.


