**ORDER**

The State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, states the following:

**JURISDICTION**

1. The Insurance Commissioner administers and enforces all provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59 § 1301 et seq.
2. Provided that all liability on outstanding bonds has been extinguished and upon written application, the Insurance Commissioner is authorized to release the deposits of a professional bondsman by written order. OKLA. STAT. tit. 59 § 1306(A)(5) and (6).

**FINDINGS OF FACT**

1. Dennis Wharton is a licensed professional bail bondsman (license number 800371/200242) in the State of Oklahoma. Dennis Wharton was licensed as a professional bondsman on November 13, 1997. However, he voluntarily surrendered his professional license on July 19, 2007. Dennis Wharton remains a licensed bondsman with the authority to write cash bonds and surety bonds.
2. In accordance with OKLA. STAT. tit. 59 § 1306(A)(3), Dennis Wharton has a One Hundred Seventy-five Thousand Dollars (\$175,000.00) security deposit with the Insurance Commissioner.
3. Dennis Wharton's current outstanding liability as of January 31, 2008 is zero. (Exhibit 1)
4. Dennis Wharton has submitted a written application for the release of his security deposit. (Exhibit 2)

5. That the Department has received certificates of non-liability from the Clerk of all Seventy-Seven (77) District Courts of Oklahoma and the two (2) Municipal Courts of Record in Oklahoma indicating that Dennis Wharton has no outstanding liability in the State of Oklahoma (Exhibit 3).

**CONCLUSIONS OF LAW**

1. That pursuant to OKLA. STAT. tit. 59, § 1306(A)(5), any deposit made by a professional bondsman shall be released and returned by the Oklahoma Insurance Commissioner to the professional bondsman only upon extinguishment of all liability on outstanding bonds.

2. That pursuant to OKLA. STAT. tit. 59, 1306(A) (6), no release of deposits to a professional bondsman shall be made by the Oklahoma Insurance Commissioner except upon written application and the written order of the Commissioner.


3. That Dennis Wharton has complied with the required provisions set out in OKLA. STAT. tit. 59, § 1306(A)(5) and (6).

**ORDER**

IT IS THEREFORE ORDERED by the Insurance Commissioner that the deposit of Dennis Wharton as set forth herein above in the amount of One Hundred Seventy-five Thousand Dollars (\$175,000.00) shall be and is hereby released, upon the signing of a receipt for the return of the deposit to Dennis Wharton.
