ORDER

The State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, states the following:

JURISDICTION

1. The Insurance Commissioner administers and enforces all provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59 § 1301 et seq.
2. Provided that all liability on outstanding bonds has been extinguished and upon written application, the Insurance Commissioner is authorized to release the deposits of a professional bondsman by written order. OKLA. STAT. tit. 59 § 1306(A)(5) and (6).

FINDINGS OF FACT

1. Veda King is a licensed professional bail bondsman (license number 801857/88751) in the State of Oklahoma. Veda Fern was licensed as a professional bondsman on August 1, 1985. However, she voluntarily surrendered her professional license on August 30, 2006. Veda King remains a licensed bondsman with the authority to write surety bonds.
2. In accordance with OKLA. STAT. tit. 59 § 1306(A)(3), Veda King has a Forty-one Thousand Dollars (\$41,000.00) security deposit with the Insurance Commissioner.
3. Veda King's current outstanding liability as of May, 31, 2008 is zero. (Exhibit 1)
4. Veda King has submitted a written application for the release of her security deposit. (Exhibit 2)
5. That the Department has received certificates of non-liability from the Clerk of all Seventy-Seven (77) District Courts of Oklahoma and the two (2) Municipal Courts of Record in Oklahoma indicating that Veda King has no outstanding liability in the State of Oklahoma (Exhibit 3).

CONCLUSIONS OF LAW

1. That pursuant to OKLA. STAT. tit. 59, § 1306(A)(5), any deposit made by a professional bondsman shall be released and returned by the Oklahoma Insurance Commissioner to the professional bondsman only upon extinguishment of all liability on outstanding bonds.

2. That pursuant to OKLA. STAT. tit. 59, 1306(A) (6), no release of deposits to a professional bondsman shall be made by the Oklahoma Insurance Commissioner except upon written application and the written order of the Commissioner.

3. That Veda King has complied with the required provisions set out in OKLA. STAT. tit. 59, § 1306(A)(5) and (6).

ORDER


IT IS THEREFORE ORDERED by the Insurance Commissioner that the deposit of Veda King as set forth herein above in the amount of Forty-One Thousand Dollars (\$41,000.00) shall be and is hereby released, upon the signing of a receipt for the return of the deposit to Veda King.
