CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800985/199271.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file her June 2008 International Fidelity Insurance Company monthly surety reports by July 15, 2008.
2. Respondent failed to file her July 2008 International Fidelity Insurance Company monthly surety report by August 15, 2008.

CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her June 2008 and July 2008 International Fidelity Insurance Company monthly surety reports.

ORDER AND CONSENT


IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured**.

IT IS FURTHER ORDERED THAT Respondent is to file her June and July 2008 International Fidelity Insurance Company monthly surety reports immediately. If they are not received by Petitioner by October 15, 2008, Respondent's license will be suspended and will remain suspended until the reports are filed.


