CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 40034340.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file his June 2008 Seneca Insurance Company monthly surety report by July 15, 2008. Said report was received by Petitioner on September 2, 2008.
2. Respondent failed to file his July 2008 Seneca Insurance Company monthly surety report by August 15, 2008.

CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his June and July 2008 Seneca Insurance Company monthly surety report.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured**.

IT IS FURTHER ORDERED that Respondent is to file his July 2008 Seneca Insurance Company monthly surety report immediately. If Petitioner does not receive the report by October 15, 2008, his license will be suspended and will remain suspended until the report is filed.


