CONSENT ORDER

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800518/200251.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file his June 2008 American Contracts Indemnity Company monthly surety report and his June 2008 monthly cash report by July 15, 2008. Said reports were postmarked on July 28, 2008 and received by Petitioner on July 30, 2008.
2. Respondent failed to file his July 2008 professional monthly report by August 15, 2008. Said report was postmarked on August 18 and received by Petitioner on August 21, 2008.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his June 2008 American Contracts Indemnity

Company monthly surety report and his June 2008 monthly cash and his July 2008 professional monthly report

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined in the amount of **One Hundred and No/100 Dollars (\$100.00)**.
