CONSENT ORDER

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 802176/199901.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file her July 2008 monthly cash report and her July 2008 simplified surety monthly report by August 15, 2008. Both reports were hand delivered on October 21, 2008.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her July 2008 monthly cash report and her

July 2008 simplified surety monthly report.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is hereby **Censured** and fined in the amount of **One Hundred and No/100 Dollars (\$200.00)**. The fine is to be paid immediately.
