ORDER

The State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, states the following:

JURISDICTION

1. The Insurance Commissioner administers and enforces all provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59 § 1301 et seq.
2. Provided that all liability on outstanding bonds has been extinguished and upon written application, the Insurance Commissioner is authorized to release the deposits of a professional bondsman by written order. OKLA. STAT. tit. 59 § 1306(A)(5) and (6).

FINDINGS OF FACT

1. Billy Jack Gosting was a licensed professional bail bondsman (license number 803463/52133) in the State of Oklahoma. Billy Jack Gosting was licensed as a professional bondsman on October 22, 1984. Billy Jack Gosting passed away on December 28, 2003.
2. In accordance with OKLA. STAT. tit. 59 § 1306(A)(3), Billy Jack Gosting has a Seventy-one Thousand Dollars (\$71,000.00) security deposit with the Insurance Commissioner and Six Thousand Five Hundred Fifty-six and 91/100 (\$6,556.91) in a special bail bond account.

3. On or about February 10, 2005, the District Court of Kay County in Case Number PB-2004-126 issued Order Allowing Final Account, Ratification of Determination of Heirs-at-Law, Devisees and Legatees and Decree of Distribution. (Exhibit A) In said Order, Mr. Gosting's spouse, Sarah Jeanette Gosting (hereinafter Jan Gosting), is the sole beneficiary of his estate.

3. Billy Jack Gosting's current outstanding liability as of August 31, 2008 is zero. (Exhibit B)

4. Jan Gosting has submitted a written application for the release of Billy Jack Gosting's security deposit. (Exhibit C)

5. That the Department has received certificates of non-liability from the Clerk of all Seventy-Seven (77) District Courts of Oklahoma and the two (2) Municipal Courts of Record in Oklahoma indicating that Billy Jack Gosting has no outstanding liability in the State of Oklahoma (Exhibit D).

CONCLUSIONS OF LAW

1. That pursuant to OKLA. STAT. tit. 59, § 1306(A)(5), any deposit made by a professional bondsman shall be released and returned by the Oklahoma Insurance Commissioner to the professional bondsman only upon extinguishment of all liability on outstanding bonds.

2. That pursuant to OKLA. STAT. tit. 59, 1306(A) (6), no release of deposits to a professional bondsman shall be made by the Oklahoma Insurance Commissioner except upon written application and the written order of the Commissioner.


3. That Jan Gosting as full beneficiary to Billy Jack Gosting has complied with the required provisions set out in OKLA. STAT. tit. 59, § 1306(A)(5) and (6).

ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner that the deposit of Billy Jack Gosting as set forth herein above in the amount of Seventy-One Thousand Dollars (\$71,000.00) and the additional Six Thousand Five Hundred Fifty-six and 91/100 (\$5,656.91) in the Oklahoma Insurance Department special bail bond account marked for Billy Jack Gosting shall be and is hereby released to Jan Gosting, upon the signing of a receipt for the return of the deposit to Jan Gosting.
