CONSENT ORDER

The Petitioner, the State of Oklahoma, ex rel. Kim Holland, and the Respondent, Seabright Insurance Company ("Seabright"), enter into this Consent Order as a voluntary settlement of the issues raised in the above styled matter.

JURISDICTION

1. Kim Holland is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. § 101 et seq., including 36 O.S. § 987(A).

2. Respondent, Seabright, is a foreign insurer, licensed in the State of Oklahoma, holding Oklahoma certificate of authority number 4125.

3. Respondent has been informed of its rights, including its right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement of the issues and questions raised

in the above styled case.

STIPULATIONS OF FACT

1. Respondent is a foreign insurer licensed in the State of Oklahoma holding certificate of authority number 4125.
2. Kemper Employers Insurance Company ("Kemper") an Illinois domiciled insurer admitted in Oklahoma, legally changed its name to Seabright Insurance Company effective November 20, 2003.
3. On December 17, 2003, Kemper made application with the financial division of the Oklahoma Insurance Department ("OID") for an amended certificate of authority to reflect the name change.
4. After the name change effective November 20, 2003, Seabright continued using manual pages, forms and loss costs multiplier filed and approved under the Kemper name rather than Seabright Insurance Company.
5. Seabright issued approximately twenty (20) workers' compensation policies between 2003 and 2008 using form filings and the loss cost multiplier approved for use by Kemper.

VIOLATIONS OF LAW

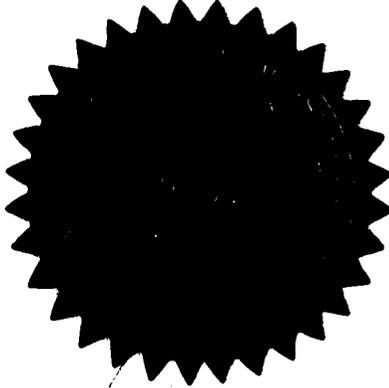
Respondent violated 36 O.S. § 987(A) and (C) by failing to file rates and loss cost multiplier under the name of Seabright Insurance Company. Respondent also violated 36 O.S. §§ 3610 and 3613 as well as OAC 365:15-7-3; 365:15-7-5 and 365:15-7-10 by using form filings made by Kemper.

ORDER

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the

Insurance Commissioner and CONSENTED to by the Respondent that the Respondent is hereby CENSURED.

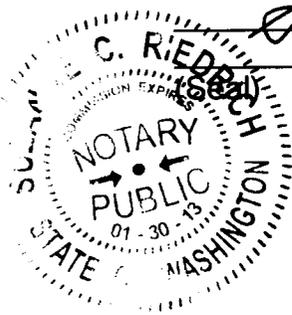

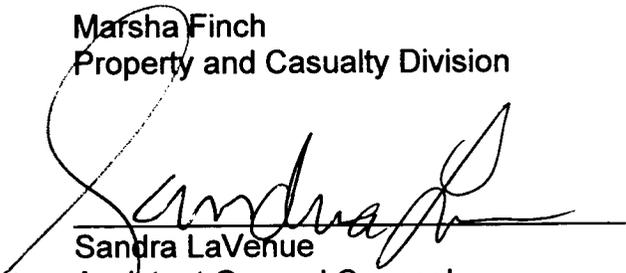
