CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Roche Surety & Casualty Company, Inc. (hereinafter Respondent), and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed surety in the State of Oklahoma holding license number 0010.
3. That Respondent has been apprised of its rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. On or about January 18, 2008, an appearance bond was issued as follows:

BAIL BONDSMAN:	Sharon Weeks
INSURER:	Roche Surety & Casualty Company, Inc.

BOND AMOUNT: \$10,000.00

2. On or about January 23, 2008, the bond forfeiture was forfeited and an Order and Judgment of Forfeiture was issued.

3. The Defendant was not returned to custody within ninety (90) days nor were the forfeitures paid within ninety-one (91) days.

4. The forfeiture was untimely paid on October 24, 2008.

CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1332(D) by failing to deposit cash or other valuable securities in the face amount of the bond with the Court Clerk ninety-one (91) days from receipt or mailing of the Order and Judgment of Forfeiture from the Court Clerk.

ORDER AND CONSENT




