CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Ayesha Jenkins. (hereinafter Respondent), and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 263635.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. On or about February 16, 2008, an appearance bond was issued as follows:

INSURER:	Safety National Casualty Corporation

BOND AMOUNT: \$250.00

2. On or about June 27, 2008, the bond forfeiture was forfeited and an Order and Judgment of Forfeiture was issued.

3. The Defendant was not returned to custody within ninety (90) days nor were the forfeitures paid within ninety-one (91) days.

4. The forfeiture was untimely paid on October 24, 2008.

5. Respondent failed to timely file her May 2008 Safety National Casualty Corporation monthly surety report and her May 2008 Roche Surety and Casualty monthly surety report by June 16, 2008. Respondent filed her May 2008 Roche Surety and Casualty monthly surety report on August 18, 2008. To date, Petitioner has not received Respondent's May 2008 Safety National Casualty Corporation monthly surety report.

6. Respondent failed to timely file her June 2008 Safety National Casualty Corporation monthly surety report and her June 2008 Roche Surety and Casualty monthly surety report by July 15, 2008. Respondent filed her June 2008 Safety National Casualty Corporation monthly surety report on July 18, 2008 and her June 2008 Roche Surety and Casualty monthly surety report on August 18, 2008.

7. Respondent failed to timely file her July 2008 Safety National Casualty Corporation monthly surety report and her July 2008 Roche Surety and Casualty monthly surety report by August 15, 2008. Respondent filed both reports on August 18, 2008.

8. Respondent failed to timely file her August 2008 Safety National Casualty Corporation monthly surety report and her August 2008 Roche Surety and Casualty monthly surety report by September 15, 2008. Respondent filed both reports on October 15, 2008.

9. Respondent failed to timely file her October 2008 Safety National Casualty Corporation monthly surety report and her October 2008 Roche Surety and Casualty monthly surety report by November 17, 2008. Respondent filed said reports on December 11, 2008.

CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1332(D) by failing to deposit cash or other valuable securities in the face amount of the bond with the Court Clerk ninety-one (91) days from receipt or mailing of the Order and Judgment of Forfeiture from the Court Clerk.

2. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B) and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her May, June, July, August and October 2008 Safety National Casualty Corporation monthly surety reports and her October 2008 Roche Surety and Casualty monthly surety reports.


ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that it shall be and hereby is fined in the amount of Five Hundred and No/100 Dollars (\$500.00). The fine is to be paid in full by May 1, 2009. If Respondent fails to pay the fine by May 1, 2009, her license will be immediately suspended and will remain suspended until the fine is paid in full.


