**ORDER OF CENSURE AND
NOTICE OF RIGHT TO HEARING**

COMES NOW the State of Oklahoma, ex rel., Kim Holland, Insurance Commissioner, by and through Assistant General Counsel John Mahoney and alleges and states as follows:

JURISDICTION

1. Kim Holland is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004, and the Oklahoma Bail Bond Code 59 O. S. §§ 1301-1340.
2. Respondent, William Tucker was a licensed bail bondsman in the State of Oklahoma holding license number 800951/199286. However, he surrendered his license on May 8, 2008. Pursuant to Okla. Stat. tit. 59, § 1310(E), Petitioner retains jurisdiction over Respondent's bail bond matters for two (2) years after his surrender date.

ALLEGATIONS OF FACT

1. 1. On or about December 14, 2006, an appearance bond was issued as follows:

Defendant:	Daniel Turner
Case Number:	CM-2005-860
City/County:	Payne County
Bondsman:	William Tucker
Insurer:	Sam Goad

Power Number: 30830
Bond Amount: \$2,000.00

2. On or about May 6, 2008, the bond was forfeited and an Order and Judgment of Forfeiture was issued.
3. The Defendant was not returned to custody within ninety (90) days nor was the forfeiture paid within ninety-one (91) days.
4. The forfeiture was untimely paid on November 10, 2008.

ALLEGED VIOLATIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1332(D) by failing to deposit cash or other valuable securities in the face amount of the bond with the Court Clerk ninety-one (91) days from receipt or mailing of the Order and Judgment of Forfeiture from the Court Clerk.

ORDER


IT IS THEREFORE ORDERED that Respondent has violated 59 O.S. §§ 1310(A)(21) and 1310(A)(27). **Respondent William Tucker is CENSURED and fined in the amount of Four Hundred and No/100 Dollars (\$400.00).** Petitioner is ordered not to issue any new or renewal license to Respondent until the fine is paid in full. Respondent is further notified that Respondent may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to John Mahoney, Oklahoma Insurance Department, Legal Division, Post Office Box 53408, Oklahoma City, Oklahoma 73152-3408 and state the basis for requesting the hearing.

Further, if Respondent does not request a hearing within the 30 days allotted this Order shall be a **FINAL ORDER** on the 31st day following the receipt of the Order. Respondent may


request a court reporter to be present at and record the hearing concerning the emergency action.

All costs associated with the court reporter shall be borne by Respondent.


