STIPULATIONS OF FACT

1. Respondent failed to file his August 2008 Fairmont Specialty Insurance Company monthly surety report by September 15, 2008. Petitioner received Respondent's August 2008 Fairmont Specialty Insurance Company monthly surety report on October 15, 2008.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his August 2008 Fairmont Specialty

Insurance Company monthly surety report.
