**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Tamara Wagoner (hereinafter Respondent), and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 40015307.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to file her August 2008 monthly property report and her August 2008 simplified monthly surety report September 15, 2008.
2. Respondent failed to file her September 2008 monthly property report and her September 2008 simplified monthly surety report by October 15, 2008.
3. Respondent failed to file her October 2008 monthly property report and her October 2008 simplified monthly surety report by November 17, 2008.

4. Respondent filed her September 2008 and her October 2008 monthly property reports and her October 2008 simplified monthly surety reports on December 18, 2008.

**CONCLUSIONS OF LAW**


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her August 2008, September 2008, and October 2008 monthly property reports and her October 2008 simplified monthly surety reports.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is hereby **Censured**.

IT IS FURTHER ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall immediately file her August 2008 monthly property report and her August 2008 simplified monthly surety report. If Respondent fails to file said reports by February 15, 2009, her license will be suspended and will remain suspended until the reports are filed.


