STIPULATIONS OF FACT

1. Respondent failed to file his August 2008 Allegheny Casualty Company monthly surety report and his August 2008 cash report by September 15, 2008. As of the date of filing of this Notice, the reports have yet to be received.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file August 2008 Allegheny Casualty Company

monthly surety report and his August 2008 cash report.

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured**.
