2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800611/199177.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file her September 2008 Allegheny Casualty Company, Accredited Surety & Casualty Company, and American Contractors Indemnity Company monthly surety reports. Petitioner received the report on October 20, 2008. The reports were postmarked on October 16, 2008.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA.

ADMIN. CODE 365:25-5-36 by failing to timely file her September 2008 Allegheny Casualty Company, Accredited Surety & Casualty Company, and American Contractors Indemnity Company monthly surety reports.


ORDER AND CONSENT




