**CONSENT ORDER**

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 803036/200034.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to file his September 2008 monthly professional report, his September 2008 monthly simplified surety report, and his September 2008 monthly cash report by October 15, 2008. Petitioner received the reports on October 20, 2008. The reports were postmarked on October 17, 2008.

**CONCLUSIONS OF LAW**


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA.

ADMIN. CODE 365:25-5-36 by failing to timely file his September 2008 monthly professional report, his September 2008 monthly simplified surety report, and his September 2008 monthly cash report.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is hereby **Censured**.


