**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Billy Hutson (hereinafter Respondent), and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800850/123078.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to file his September 2008 simplified professional report, his September 2008 simplified surety report, and his September 2008 cash monthly report by October 15, 2008. Petitioner received his September 2008 simplified professional report, his September 2008 simplified surety report, and his September 2008 cash monthly report on October 20, 2008. The reports were postmarked on October 16, 2008.

**CONCLUSIONS OF LAW**


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his file his September 2008 simplified professional report, his September 2008 simplified surety report, and his September 2008 cash monthly report.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured** fined in the amount of **Three Hundred and No/100 Dollars (\$300.00)**. The fine is to be paid immediately.

IT IS FURTHER ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that any additional complaints from the Bail Bond Division regarding Respondent failing to timely file his monthly reports will result in an increased fine per untimely filed report.
