 2. Respondent failed to file her December 2008 cash monthly report by January 15, 2009.
 3. Respondent filed her November and December 2008 cash monthly reports on February 14, 2009.


CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her November 2008 and December 2008 cash monthly reports.


