CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Brent Smith (hereinafter Respondent), and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license numbers 800987/199509.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file his November 2008 Safety National Casualty Corporation monthly surety report by December 15, 2008. The report was postmarked on December 16, 2008 and received by Petitioner on December 19, 2008.
2. Respondent failed to file his December 2008 Safety National Casualty Corporation monthly surety report by January 15, 2009. The report was postmarked on January 16, 2009 and received by Petitioner on January 21, 2009.


CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his November 2008 and December 2008 Safety National Casualty Corporation monthly surety reports.


ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured**.




