**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Brent Smith (hereinafter Respondent), and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent Fredalene Holder ("Holder") is a licensed bail bondsman in the State of Oklahoma holding license number 109067, formerly 800048.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Holder's county of residency/office where her license is registered, pursuant to 59 O.S. § 1320, is Pushmataha County, Oklahoma.

2. A bondsman is permitted to write bonds on no more than ten (10) defendants per year in any of the seventy-six (76) counties in the State of Oklahoma in which the bondsman cannot register his license. The limitation does not extend to counties which do not have a licensed bondsman registered in the county, 59 O.S. § 1320(B).

3. Holder issued the following bonds in the month of October, 2008:

4. Choctaw County, Oklahoma currently has four bondsman registered with the county sheriff, and these same four bondsmen were continually registered with the Choctaw County Sheriff during the year 2008 and at all times pertinent to this matter.


#### CONCLUSIONS OF LAW

1. Respondent Fredalene Holder exceeded the statutory limit, embodied in 59 O.S. § 1320(B) and OAC 365:25-5-38, of ten (10) bonds per year, a licensed bail bondsman may write in any county in the State of Oklahoma, other than his/her home county by issuing eleven (11) bonds in Choctaw County, Oklahoma during October 2008.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and  
CONSENTED to by the Respondent that he shall be and hereby is censured and fined in  
the amount of **One Hundred and No/100 Dollars (\$100.00)**. Fine is to be paid  
immediately.


