**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Loy Collier (hereinafter Respondent), and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 199776 formerly 800662.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Pursuant to 59 O.S. § 1314 and OAC 365:25-5-36, Respondent is required to report every bond written within fifteen (15) days after the end of the preceding month for each component of his license.

2. Respondent failed to file his December 2008 cash monthly report and his December 2008 simplified surety monthly report by January 15, 2009.

3. Respondent's reports were postmarked January 16, 2009 and received by the Oklahoma Insurance Department ("Department") on January 22, 2009.

### CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his December 2008 cash and simplified surety monthly reports.

### ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured**.
