**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Michael Galmor (hereinafter Respondent), and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 200251, formerly 800515.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Pursuant to 59 O.S. § 1314 and OAC 365:25-5-36, Respondent is required to report every bond written within fifteen (15) days after the end of the preceding month for each component of his license.

2. Respondent failed to file his December 2008 professional monthly report by January 15, 2009.

3. Respondent's report was postmarked January 26, 2009 and received by the Oklahoma Insurance Department ("Department") on January 30, 2009.

### CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his December 2008 professional monthly report.

### ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined in the amount of **Two Hundred Fifty Dollars (\$250.00)**. Fine is to be paid immediately.


