CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Billy Dismuke (hereinafter Respondent), and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 144708, formerly 800254.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. A review of the Oklahoma County Court Clerk records revealed two bonds issued by Respondent which he had not reported to the Oklahoma Insurance Department ("Department") as required by 59 O.S. § 1314. The Department contacted Respondent by certified mail and advised him of his failure to report the bonds and

ordered him to report the bonds by March 17, 2009. Respondent failed to report the bonds by March 17, 2009.

CONCLUSIONS OF LAW

1. Respondent violated 59 O.S. § 1310(A)(22), 1314(B) and OAC 365:25-5-36, by failing to timely report two (2) bonds.
2. Respondent violated 59 O.S. § 1310(A)(21), by failing to respond to a properly addressed notification from the Insurance Commissioner.

ORDER AND CONSENT


IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined **Two Hundred and No/100 Dollars (\$200.00)**. Fine is to be paid immediately.

IT IS FURTHER ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he must report the bonds for Dinah Owens and Joseph Jenkins by June 15, 2009. If the bonds are not reported by June 15, 2009, his license will be suspended and will remain suspended until the bonds are reported.






