CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance

Commissioner, and the Respondent Lori Burton (hereinafter Respondent), and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 199806 formerly 800164.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Pursuant to 59 O.S. § 1314 and OAC 365:25-5-36, Respondent is required to report every bond written within fifteen (15) days after the end of the preceding month for each component of her license.

2. Respondent failed to file her February 2009 cash monthly report and her February 2009 simplified surety monthly report by March 16, 2009.

3. Respondent mailed her February 2009 cash monthly report and her February 2009 simplified surety monthly report on April 2, 2009. Said reports were received by Petitioner on May 6, 2009.

CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her February 2009 cash monthly report and her February 2009 simplified surety monthly report.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is **censured**.




