The Temporary Practice Permit Application fee is \$50.00 per appraisal report rendered, up to a maximum of \$150.00 per appraisal assignment of one or more appraisals performed under a single contract. A temporary practice permit is issued on the basis of assignment, and there is no associated end date on the permit other than completion of the assignment.
