ADMINISTRATIVE ORDER

On June 8, 2012, the above-captioned case came on for hearing at the office of the Oklahoma Insurance Department, 3625 N.W. 56th Street, Suite 100, Oklahoma City, Oklahoma 73112, and was concluded on the same date. Oklahoma Insurance Commissioner John D. Doak appointed the undersigned independent hearing examiner to preside at the hearing as a quasi-judicial officer. The hearing was recorded electronically by employees of the Oklahoma Insurance Department. Petitioner was represented by Assistant General Counsel William G. Combs. Allen appeared in person and represented himself. Testimony was taken and arguments were heard. The hearing examiner finds as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.

2. Respondent Quenzell Allen is a licensed bail bondsman in the State of Oklahoma holding license number 199474.

FINDINGS OF FACT

1. On or about January 28, 2011, the Oklahoma Insurance Department (“Department”) mailed a letter to Respondent informing him that his December 2010 monthly surety report, which was due by January 15, 2011, had not been received and instructing him to respond to the Department by February 7, 2011. The letter was sent via certified mail with return receipt requested. Respondent received the letter on February 8, 2011.

2. Respondent’s December 2010 monthly surety report was not received by the Department until February 17, 2011.

3. On or about March 2, 2011, the Department mailed a letter to the Respondent, via certified mail with return receipt requested, informing him that his January 2011 monthly surety report, which was due February 15, 2011, had not been received and instructing him to respond to the Department by March 15, 2011. The letter was returned to the Department marked “unclaimed” after three (3) attempts at delivery.

4. Respondent’s January 2011 monthly surety report was not received by the Department until April 8, 2011.

5. On or about March 15, 2011, the Department mailed a letter to the Respondent, via certified mail with return receipt requested, informing him that corrections had been made to his December 2010 report and the reviewal fee, in the amount of \$679.80, that should have accompanied that report had not been received. The letter instructed Respondent to respond to the Department by March 31, 2011. The letter was returned to the Department marked “unclaimed” after three (3) attempts at delivery.

6. Respondent did not submit \$679.80 as payment for the reviewal fees due for his

December 2010 surety report until June 6, 2011.

8. Respondent's December 2010 monthly cash report, which was due January 15, 2011, was not received until June 7, 2011.

9. Respondent's January 2011 monthly cash report, which was due February 15, 2011, was not received by the Department until March 10, 2011.

10. Respondent's February 2011 monthly cash report, which was due March 15, 2011, was not received by the Department until April 8, 2011.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct and Quenzell Allen has violated 59 O.S. § 1314(B) and Oklahoma Administrative Code § 365:25-5-36 by failing to timely file monthly surety reports for December 2010, January 2011, and February 2011 and for failing to timely file monthly cash reports for December 2010, January 2011, and February 2011.

ORDER

IT IS THEREFORE ORDERED that Quenzell Allen is CENSURED.


