ADMINISTRATIVE ORDER

On January 17, 2012, the above captioned case came on for hearing at the office of the Oklahoma Insurance Department, 3625 N.W. 56th Street, Suite 100, Oklahoma City, Oklahoma and was concluded on the same date. Oklahoma Insurance Commissioner John D. Doak appointed the undersigned independent hearing examiner to preside at the hearing as a quasi-judicial officer. The hearing was recorded electronically by employees of the Oklahoma Insurance Department. Petitioner was represented by Assistant General Counsel Mark A. Willingham. Respondent appeared in person and waived his right to counsel. Exhibits were received, testimony was taken, and arguments were heard. The hearing examiner finds as follows:

FINDINGS OF FACT

1. The Insurance Commissioner has full power and authority to administer the provisions of the Oklahoma Insurance Code, 36 O.S. §§101-7004. Respondent is a licensed producer in the State of Oklahoma holding license number 7570956.
2. On or about August 24, 2011, an inquiry regarding a claim which arose under insurance an insurance contract was forwarded by the Oklahoma Insurance Department to Respondent.
3. The thirtieth (30th) day after the date of inquiry was September 23, 2011.
4. Respondent has failed to provide any response to the inquiry within the thirty (30) day period.

CONCLUSIONS OF LAW

1. The Commissioner has jurisdiction over this matter pursuant to 36 O.S. § 101 et seq. The proceedings were commenced and conducted in accordance with the applicable provisions of the Oklahoma Administrative Procedures Act 75 O.S. §§ 250-323, and the Oklahoma Insurance Code, 36 O.S. § 101 et seq.

2. Respondent violated 36 O.S. § 1250.4(B) by failing to furnish an adequate response to an inquiry from the Commissioner within thirty (30) days from the date of the inquiry.

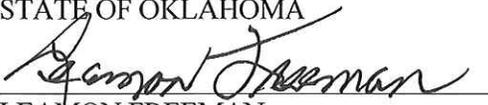
ORDER
