2. On January 12, 2012, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the court on January 19, 2012, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Merrill received a copy of the Order and Judgment of Forfeiture on February 2, 2012.

4. The mailing of the Order and Judgment of Forfeiture to Hoffmann was returned "Unclaimed."

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Respondents was Thursday, May 3, 2012. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor was the face amount of the forfeited bond deposited with the court clerk within ninety-one (91) days.

6. As of the date of this Conditional Order, the forfeited bail bond has not been paid or otherwise set aside or exonerated.

7. Hoffmann did not provide Merrill's name and address or her own address on the appearance bond.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face

amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

2. Hoffmann has violated 59 O.S. § 1316(E) by not providing Merrill's name and address and her own address on the appearance bond.

3. Under 59 O.S. § 1310(B), any person or entity violating a provision of the Bail Bond Act may be subject to a civil penalty ranging from \$250 to \$2,500.

ORDER

IT IS THEREFORE ORDERED that Raymond Merrill and Ryanne Christine Hoffmann are each FINED Two Hundred Fifty Dollars (\$250.00).

IT IS FURTHER ORDERED that pursuant 59 O.S. § 1332 the face amount of the bond, Four Hundred Ninety-Eight Dollars (\$498.00), shall be withdrawn from the deposit placed with the State of Oklahoma by Raymond Merrill as reserve to meet sums due on forfeiture. The sums withdrawn are to be forwarded to the Owasso Municipal Court Clerk for payment of the bond in case number 12284E and 12285E, Defendant Jarred Allen Morton. Such sums shall not be withdrawn from the deposit of Raymond Merrill if the bond forfeiture is paid or otherwise set aside within 30 days of receipt of this Order.

Respondents are notified that they may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to William G. "Buddy" Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Street, Suite 100, Oklahoma City, Oklahoma 73112, and **give an explanation of Respondent's actions described herein and any defenses thereto.** Upon such a request, a hearing will be

conducted before an independent hearing examiner in accordance with the Bail Bond Code, 59 O.S. §§ 1301 et seq., and the Oklahoma Administrative Procedures Act, 75 O.S. §§ 301 et seq. Pursuant to 59 O.S. § 1311.1(F), “[t]he ordinary fees and costs of such hearing examiner may be assessed by the hearing examiner against the respondent, unless the respondent is the prevailing party.”

If either Respondent fails to pay the fine ordered herein or request a hearing within 30 days of receipt of this Order, this Order shall become a **FINAL ORDER** on the 31st day following the receipt of the Order, that Respondent’s license shall be **SUSPENDED**, and the face amount of the bond forfeiture shall be withdrawn from Merrill’s deposit and forwarded to the Owasso Municipal Court Clerk.


