

3. The appearance bonds did not indicate receipt of the cash collateral by Respondent.

4. On May 9, 2012, Yegge appeared in court, pled guilty, and was given a deferred sentence on all three counts in Tulsa County case number CM-2012-412. Yegge's three appearance bonds were exonerated.

5. Approximately three weeks later, Yegge contacted Respondent to ask for the return of his collateral payment. Yegge did not receive a return of \$1,500 at that time.

6. On August 2, 2012, Yegge filed a complaint against Respondent alleging the facts above.

7. The Oklahoma Insurance Department ("Department") sent Respondent a letter via certified mail but the mailing was returned to the Department. Respondent had changed her mailing address on file with the Department.

8. On August 14, 2012, the Department sent another letter to Respondent via certified mail. Respondent signed for the certified letter on August 21, 2012. The letter instructed Respondent to respond in writing within 10 business days of receipt of the letter.

9. Respondent replied on September 10, 2012, showing that she had sent a check to Yegge in the amount of \$1,500.

10. On September 14, 2012, Yegge notified the Department that he received \$1,500 from Respondent.

CONCLUSIONS OF LAW

1. Respondent has violated 59 O.S. § 1310(A)(20) for failing to return collateral security to the principal when the principal was entitled thereto.

2. Respondent has violated 59 O.S. § 1310(A)(19) for failing to immediately return collateral upon final termination of her liability on the bond.

3. Respondent has violated 59 O.S. § 1322 by failing to list on the appearance bond the cash collateral received.

4. Any bail bondsman or bail surety company violating any provision of the Bail Bond Act “may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.” 59 O.S. § 1310(B).

ORDER

IT IS THEREFORE ORDERED that Diana L. Teague is fined Two Hundred Fifty Dollars (\$250.00).

IT IS FURTHER ORDERED that this Order constitutes disciplinary action and may be used in any subsequent hearings by the Insurance Department. In the event other misconduct is reported to the Department, this Order may be used as evidence against Respondent to establish a pattern of behavior and for the purpose of proving additional acts of misconduct.

Respondent is further notified that she may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and **give an explanation of Respondent’s actions described herein and any defenses thereto.**


If Respondent does not request a hearing within the 30 days allotted, this Order shall
