

OKLAHOMA REAL ESTATE APPRAISER BOARD

UNIFORM SCHEDULE OF SUGGESTED PENALTIES FOR VIOLATIONS OF THE OKLAHOMA CERTIFIED REAL ESTATE APPRAISERS ACT AND PROMULGATED RULES

A. Purpose: The purpose of this schedule is to achieve more consistency in the discipline to be recommended to, and to be imposed by, the Board through disciplinary proceedings and to provide appropriate guidance to prosecutors and disciplinary hearing panels in connection with disciplinary proceedings. To accomplish this purpose, the Board has adopted this uniform schedule of suggested penalties for specific violations of the Oklahoma Certified Real Estate Appraisers Act (59 O.S. Sec. 858-701 et seq., hereinafter referred to as the "Act") and the Rules promulgated thereunder by the Board (OAC 600: 10-1-1 et seq., hereinafter referred to as the "Rules").

B. Usage:

1. The schedule of suggested penalties are merely recommended guidelines. Mitigating and aggravating circumstances and other factors may necessitate deviations from this schedule of suggested penalties.

2. Disciplinary sanctions should be within the recommended guidelines for a particular act, omission or violation of the Act and/or the Rules unless the reason for departure from the recommended terms is generally set forth in the recommendation of the Hearing Panel, the proposed agreed settlement recommended by a prosecutor, or order of the Board. Dollar amounts specified for fines are intended to indicate maximum amounts for the specific category.

3. Aggravating or mitigating circumstances justifying departure from this schedule of suggested penalties may include, but are not limited to, the following:

- a. Nature and severity of the act(s), omission(s), violation(s), or crime(s) under consideration.
- b. Actual or potential harm to any consumer, client or the general public.
- c. Prior disciplinary record.
- d. Number and/or variety of current act(s), omission(s) or violations.
- e. Mitigation evidence.
- f. Rehabilitation evidence.
- g. Time passed since the act(s), omission(s) or violation(s) occurred.
- h. Whether or not the respondent cooperated with the Board's investigation, other law enforcement or regulatory agencies, and/or the injured party or parties.
- i. Recognition by respondent of his or her wrongdoing and demonstration of corrective action to prevent recurrence.

4. USPAP citations in this schedule do not include references to Standards 3, 4, 5 or 6 or their supporting standards rules. Requirements in these Standards, however, tend to be very

similar to those contained in Standards 1 and 2. Accordingly, the recommendations for Standards 1 and 2 should be used as guidance for violations of Standards 3 through 6.

C. For use in applying this schedule, ordinary negligence is defined as the failure to exercise the ordinary care a reasonably prudent person would exercise under the circumstances; it is akin to neglect. Gross negligence in the schedule is defined as failure to exercise even the slightest care; it is a complete indifference to the consequences of the act, omission or violation.

E. Probation Guidelines:

1. Commence only after corrective education is completed.
2. Completion time for corrective education:
 - a. 30 days for one online course or seminar; 60 days for a live course.
 - b. 30 days added for each additional online course or seminar; 60 days for a live course.

Note: Corrective Education can be ordered as its own sanction and does not have to be ordered in conjunction with probation. But, probation may not begin until any associated corrective education is completed.

3. Probation period may be.
 - a. stated as a set number of months; or.
 - b. passing review of a specific number of appraisals with no associated time frame.
4. Review
 - a. May be defined as a Standard 3 review.
 - b. Respondent may be required to reimburse the Board for Standard 3 review expense.
