2. Respondent has consistently violated the Bail Bond Code Cases 14-0806-DIS, 14-0979, 14-0979-DIS, 15-0759-DIS

3. Respondent's license was suspended in Case 15-0635 on August 6, 2015 and will remain suspended until Respondent complies with all of the the Insurance Commissioner orders.

4. Failure to comply will result in permanent revocation of Respondent's license.

5. Pursuant to 59 O.S. § 1310(B), any person violating any provision of Sections 1301 through 1340 may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

ORDER

IT IS THEREFORE ORDERED that Eugene Phillips is **FINED** Five Hundred Dollars (\$500.00).

Respondent is further notified that he may request a hearing within 30 days of receipt of this Order, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Julie Meaders, Deputy General Counsel, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112, and shall specify the grounds to be relied upon as a basis for relief demanded at the hearing.

If Respondent does not request a hearing within the 30 days allotted, this Conditional Administrative Order shall become a FINAL ORDER on the 31st day following Respondent's receipt of the Order.
