ORDER LIFTING SUSPENSION

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Kelley C. Callahan, and alleges and states as follows:

1. On January 27, 2016, a Conditional Administrative Order and Notice of Right to be Heard was issued. Charles David Van Brunt (“Respondent”) was fined Two Hundred Fifty and No/100 Dollars (\$250.00). The fine was to be paid immediately or Respondent could request a hearing. If the fine was not paid within the time allowed and a hearing was not requested, his bail bond license would be suspended and would remain suspended until the fine was paid.

2. Respondent received a copy of the January 27, 2016, Order on February 1, 2016.

3. Respondent failed to pay the fine or request a hearing by March 2, 2016.

3. On March 28, 2016, Respondent’s license was suspended.

2. On the April 6, 2016, the fine was paid.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that suspension of Charles David Van Brunt’s bail bond license is hereby lifted.


