RULEMAKING HEARING

A rulemaking hearing of the Oklahoma Insurance Department will be held February 25, 2010, at 9:30 a.m. in the Commissioner's Conference Room of the Offices of Insurance Commissioner Kim Holland at 2401 N.W. 23rd Street, Suite 28, Oklahoma City, Oklahoma (Shepherd Mall), to hear public comment on proposed permanent rulemaking. The proposed amendments that are the subject of this public hearing are to the following Insurance Department rules:

1. Chapter 1, Administrative Operations, Section 365:1-1-4.1; Section 365:1-7-9 and Section 365:1-9-5 (File No. 09-1745-RUL);
2. Chapter 10, Life, Accident and Health, Section 365:10-1-14; Sections 365:10-5-9, 45.1, 55, and 177; Section 365:10-15-2; Section 365:10-17-4; Sections 365:10-25-4 and 5; and Appendix CC (File No. 09-1746-RUL);
3. Chapter 15, Property and Casualty, Sections 365:15-1-3, 18, 22; Sections 365:15-7-3, 16, 31 and 32; Sections 365:15-9-3, 10, 18 and 22; and Appendix D (File No. 09-1747-RUL);
4. Chapter 25, Licensure of Producers, Adjusters, Bail Bondsmen, Companies, Prepaid Funeral Benefits, and Viatical Settlements Providers and Brokers, Sections 365:25-3-1.2, 14 through 16 and 21; Sections 365:25-5-39, 40, 44, and 50 through 58; Section 365:25-9-3; and Appendices C, M, X and Y (File No. 09-1748-RUL);
5. Chapter 40, Health Maintenance Organizations (HMO), Section 365:40-3-14 and Section 365:40-5-2 (File No. 09-1749-RUL); and
6. Chapter 45, Health Care for Oklahomans Regulation, Sections 365:45-1-1 and 2; Section 365:45-3-1; and Section 365:45-5-1 (File No. 09-1750-RUL).

Copies of the notices of proposed permanent rulemaking for the subject rules were published in the Oklahoma Register on January 15, 2010.
