The monthly report does not include the SERFF filing number. As such, we highly suggest that you e-mail your request to [Linda.Valliant@oid.ok.gov](mailto:Linda.Valliant@oid.ok.gov) and [Paula.Butler@oid.ok.gov](mailto:Paula.Butler@oid.ok.gov) well in advance of your deadline.

The request **must** identify the Filing Number, lead insurance company and the month the filing was posted. The Filing Number is identified on the report for each filing, example/ Filing: 31769. The filing number will then be converted to the SERFF filing number by Department staff at their earliest convenience.

Some of the filings will contain fewer than ten (10) pages while others will have hundreds. As such, it is the company's responsibility to set limitations as to the amount of the total expenditure.

**Although appointments are not required to view filings, it is highly suggested due to the limited space and equipment. Individuals making appointments will be given priority access to the SERFF computer and any remaining paper filings. Anyone who does not make an appointment may wait in the lobby or make an appointment for another time period.**
