IMPORTANT NOTICE FOR ALL PRODUCERS Mandatory Online Processing

The Oklahoma Insurance Department licenses all individuals conducting the business of insurance in Oklahoma. The Producer Licensing Division oversees licensing and continuing education requirements for insurance adjusters, agents and representatives.

From this page, producers can view resident and non-resident producer licensing requirements, apply for license online, via Sircon.

The Oklahoma Insurance Department, Producer Licensing Division, has switched to an all-electronic process for new license and renewal applications, agency registrations, letter of certifications requests, address changes (excluding changes from one state to another state), and CE Course Submissions by providers as of January 1, 2009. Paper applications/renewals and request for these transactions will be returned, unprocessed if received after January 1, 2009.

The following licensing filings shall be submitted electronically unless prior approval has been granted by the OID to the submitter to produce such filings in paper format. Any license types not listed below may continue to be submitted via paper format.

Please note: the list below is subject to change as license types become available through our electronic vendors.

- Resident and Non-Resident Insurance agent/producer initial and renewal license applications (Includes: Life, Accident & Health, Variable Annuity, Property & Casualty); Resident and Non-Resident license renewal applications for Insurance Consultants

- Resident and Non-Resident Insurance Business Entities (Agencies), initial and renewal license applications (Includes: Life, Accident & Health, Variable Annuity, Property & Casualty);
- Resident Limited Lines producer initial and renewal license applications;
- Resident Provisional Producer license applications;
- Non-resident Title and Aircraft Title Insurance agent/producer initial and renewal license applications;
- Resident Insurance Adjuster initial and renewal license applications;
- Resident Catastrophe (Emergency) Adjusters;
- Application/renewal for Non-Resident Adjusters licensed in a state with a Resident adjuster licensing requirement;
- All Producer Appointments; except motor service club
- All Producer Appointment Terminations; except motor service club ;
- Resident and Non Resident Surplus Lines Broker renewal applications ;
- Resident and Non Resident Viatical Settlement Broker renewal applications;
- Resident Limited Lines Entity initial and renewal license applications;
- Resident and Non Resident Business Entity Surplus Lines Broker renewal applications ;
- Resident and Non Resident Business Entity Viatical Settlement Broker renewal applications;
- Non-resident Title and Aircraft Title Insurance Entity initial and renewal license applications;
- Resident and Non Resident Business Entity Insurance Consultant renewal applications.
