The Oklahoma Insurance Department is pleased to announce the expansion of services through The National Insurance Producer Registry (NIPR). On August 27, 2010 NIPR will offer Resident Producer Licensing Initial and Renewal Applications, Resident Adjuster Licensing Initial and Renewal Applications, Reinstatement Applications for Producers and Adjusters and Non-Resident Adjuster Licensing Initial and Renewal Applications, if the applicant holds a license in their resident state.

Electronic (online) processing is available utilizing Oklahoma's licensing vendors, NIPR, Sircon Corporation or any vendor approved by the NIPR.
