CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit and the Respondent, Becky Mullings, voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent, Becky Mullings, agrees to waive her right to a hearing under the Oklahoma Administrative Procedures Act. Both parties state as follows:

- (1) The Petitioner re-states and incorporates by reference the allegations nade by the Petitioner in the Notice of Hearing filed in this matter;
- (2) The Respondent states as follows in response to the allegations of the Petitioner:
- (a) I, Becky Mullings, never, at any time committed any fraudulent activity on any mortgage loan or file.
- (b) In direct response to the allegation of signing Zac Bennett's name on Cynthia D. Clark's loan application, I was told to do so directly by Louie Fleege. I, Becky Mullings, would never have signed Zac Bennett's name if I had not felt direct pressure to do so.
- (c) I, Becky Mullings, felt like if I did not do what I was told by Jon Fleege and Louie Fleege that I would lose my job and not be able to gain other employment due to being pregnant.
- (3) The Respondent agrees to have her mortgage loan originator license, number MLO05561, revoked by the Petitioner. The Respondent shall return her nortgage loan originator license to the attention of Roy John Martin, General Counsel, Oklahoma Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112 within thirty (30) days from the date of Filing of this Consent Order.
- (4) The Respondent agrees to pay a \$750.00 civil penalty to the Petitioner. The \$750.00 civil penalty shall be made payable by check or money order to the Oklahoma Department of Consumer Credit and shall indicate the payment is for Case Number 12-0036-DIS. The \$750.00 civil penalty shall be payable in monthly installments of \$50.00 until the \$750.00 civil penalty is paid. The monthly installment payments shall be submitted to the attention of Roy John Martin, General Counsel, Oklahoma Department of Consumer Credit 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112. The first monthly installment payment of \$50.00 shall be submitted or postmarked on or before August 1, 2012 and monthly installment payments thereafter shall be submitted or postmarked on or before the first day of each month thereafter.
- (5) The Respondent shall return this Consent Order with an original signature page and original notarized verification page to the attention of Roy John Martin, General Counsel, Oklahoma Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112, which shall be received by the Petitioner on or before July 13, 2012.
