- ii. As of November 17, 2014, the Mortgage Call Report (MCR) Filing History on NMLS indicates that the following mortgage call reports were required to be filed by the Respondent:
 - (a) 2013 quarter one Oklahoma Standard Residential Mortgage Call Report (Standard MCR), filing deadline of February 14, 2014;
