**CONSENT ORDER**

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, JAR LLC d/b/a Jewelry Buying Company, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

- a. The Respondent is a registered limited liability company with the Oklahoma Secretary of State.
- b. The Respondent is a licensed precious metal and gem dealer; license number PM007516, at 6059 S. Sheridan Road, Tulsa, OK 74145.
- c. On March 18, 2015, Consumer Credit Examiner, Stephen Glasgow, conduct an inspection of the Respondent's advertisement pursuant to their precious metal and gem license.
- d. The Respondent failed to list their precious metal and gem dealer license number on their company website at: [www.thejewelrybuyingco.com](http://www.thejewelrybuyingco.com) and [www.jewelrybuyertulsa.com](http://www.jewelrybuyertulsa.com); attached and incorporated herein.
- e. The Respondent failed to list their precious metal and gem dealer license number on their Facebook page at:

<https://www.facebook.com/pages/The-Jewelry-Buying-Co> ; attached and incorporated herein.

(2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter and incorporated by reference in this Consent Order.

(3) The Respondent agrees to include the precious metal and gem dealer license number of the dealer that is issued by the Administrator for the business location at which the dealer is offering to engage as a precious metal and gem dealer, pursuant to 59 O.S. § 1533.

(4) The Respondent agrees to pay a \$100.00 civil penalty. Payment of the civil penalty shall be received, by the Department, five days prior to the hearing date in the Notice of Hearing.

(5) **Payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 15-0108-DIS and shall be addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W. 56<sup>th</sup> Street, Suite 240, Oklahoma City, Oklahoma 73112.**

(6) A file stamped copy of this Consent Order will be returned by United States mail to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(7) If the Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 1528(G) of the Precious Metal and Gem Dealer Licensing Act.
