CONSENT ORDER

 - ii. The Respondent is licensed as a mortgage loan originator in the State of Oklahoma pursuant to the SAFE Act with the following licensing information indicated by NMLS:
 - a. Oklahoma license number ML009540.
 - b. NMLS unique identifier number/company ID 893450.
 - C. Mailing address of record at 4900 Windhaven. Pkwy, Apt. 18107, The Colony, TX 75056.

- iii. The Respondent's license renewal fee was not paid on or before December 1, 2015.
- iv. The Respondent requested a renewal of their license on December 17, 2015.
- v. The Respondent has failed to pay \$160.00 in license renewal fees.
- (2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) The Respondent agrees to pay the late renewal fees of \$160.00 and a \$250.00 civil penalty, for a total of \$410.00, payable to the Oklahoma Department of Consumer Credit, on or before September 19, 2016.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16-0106-DIS and shall be addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (5) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If the Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to tile an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. §
