## CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Auto Pro of Oklahoma, LLC, d/b/a Auto Pro, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
  - i. The Respondent is registered as a domestic limited liability company in the State of Oklahoma, Oklahoma Secretary of State filing number 3512027752, active filing status.
  - ii. The Respondent transacts business at 3101 N. McArthur, Oklahoma City, OK 73122.
  - iii. On September 6, 2016, a consumer credit examiner entered the business premises of the Respondent and spoke to Mr. Ron Hokett. The examiner asked Mr. Hokett if the location offered in-house financing. Mr. Hokett did advise the examiner that the location does offer in-house financing and that the location had a permit with the Used Motor Vehicle Department.

- iv. Examiner requested a copy of a completed contract and a business card. Mr. Hokett provided a copy of a current Retail Installment Contract, Security Agreement and Disclosure Statement and a business card.
- V. The copy of the current Retail Installment Contract, Security Agreement and Disclosure statement lists the purchase of a 2006 Dodge Ram 1500 truck. The terms of the contract are ninety-two (92) bi-weekly payments in the amount of \$200.00 with an annual percentage rate of 21%. First payment was scheduled on September 3, 2015. Total sales price of the vehicle is \$19,508.31.
- vi. The Respondent maintains an Internet website at <a href="https://www.autoprookc.com">www.autoprookc.com</a>. There is an online application available for financing.
- vii. As of September 6, 2016, the Respondent was not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2).

The Respondent is licensed as of September 14, 2016. The Department received Respondent's notification filing application on September 8, 2016. Respondent was issued a notification filing permit on September 14, 2016.

- viii. The Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- (2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) The Respondent has paid the applicable registration/application fees and further agrees to pay a \$1,000.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before October 31, 2016.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16-0162-DIS and shall be

addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W.  $56^{\rm th}$  Street, Suite 240, Oklahoma City, Oklahoma 73112.

- (5) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If the Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).
